LL Tracker is the application software which works on iPhone, and get the location information from Location information satellite, accelerometer information, motion information, and pressure information periodically.

User can see the data during the acquisition, and after one. They also send the data by E-Mail and upload to our server.

The operation manual explains the specification, and how to operation about the software.

- 4.1.1. Setting invalid for the auto-lock function

iPhone has the auto-lock function, and its status changes to "lock" if the setting of "lock" is valid and users don't operate iPhone during the time of setting.

The software suspends when the status of iPhone is "lock", No data is acquired in the status.

For setting "invalid", Set "Never" for "Auto-Lock" ("Settings" -> "Display & Brightness")

4.2. How to start the software


Tap the following icon on the screen of iPhones.




After starting the software, the splash screen and monitor screen appear.


7. Data Screen


Setting screen appears by the setting screen icon on the tab.
